### COMPANY POLICY

Our company, operating in the Mesero site, has been carrying out the design, production and marketing of transformers from several years with increasing awareness of the importance of the services taken on to the community and of the significant contribution made in the environmental sector with technologically advanced products, non-polluting and with reduced environmental impact.

Our company has therefore always identified as its mission the creation of value by developing organizational and industrial processes capable of offering appropriate solutions for customers, and in a broad sense for citizens and for the territory and the surrounding environment, in the conviction that their satisfaction is of fundamental importance for the success of the company in respect of the quality of life and sustainable development.

In line with this vision, we have deemed it appropriate to adopt the principle of continuous improvement as a strategic element of our business.

Consequently, we have decided to introduce into the company the Management Systems compliant with the principles of the International Standards UNI EN ISO 9001 and UNI EN ISO 14001, in the belief that we can better guarantee an efficient supply of products and services through systematic management of business processes and perception, as well as knowledge of the needs and expectations of customers, public and private, together with the protection of the environment and the effective collaboration with the bodies in charge.

**For this purpose, we declare the following objectives as a priority:**

- o Keep the UNI EN ISO 14001 Environmental Management System active and efficient;
- o Keep the UNI EN ISO 9001 Quality Management System active and efficient
- o Maintain compliance with all applicable laws and regulations in the field of product and environment and workplace safety;
- o Pursue (as a basic principle of daily practice) continuous improvement in the field of quality and the environment (greater efficiency of work processes, reduction of environmental impact);
- o Seek the satisfaction of all those who interact with the company: customers, suppliers of goods and services, interested third parties;
- o Reaching efficiency targets (compliance with scheduled times, and relative reduction of times), constantly adapting the products to the needs of the market;

- Use of renewable energy from a photovoltaic system (137 kVA);
- Evaluate in advance the environmental impacts of the changes made to the plants, of the new processes and / or activities and / or services, adopting the technologies available on the market that offer the best performances where possible, and economically feasible, minimizing whenever the related environmental and separate waste collection while ensuring its control;
